WHAT DOES ADELFI DO WITH YOUR PERSONAL INFORMATION? Better banking. Higher purpose.



Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and income Account balances and payment history Transaction history and account transactions When you are <i>no longer</i> our member, we continue to share your information as described in this notice. 		
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons AdelFi chooses to share; and whether you can limit this sharing.

What we do			
How does AdelFi protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. Our employees are trained in the importance of maintaining confidentiality and member privacy.		
How does AdelFi collect my personal information?	 We collect your personal information, for example, when you: Open an account or apply for a loan Deposit money or pay your bills Use your credit or debit card We also collect your personal information from others, such as credit bureaus, affiliates, or other companies. 		
Why can't I limit all sharing?	 Federal law gives you the right to limit only: Sharing for affiliates' everyday business purposes—information about your creditworthiness Affiliates from using your information to market to you Sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. 		
Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. AdelFi has no affiliates		
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. AdelFi does not share with nonaffiliates so they can market to you 		
Joint marketing	 A formal agreement between nonaffiliated financial companies that together market financial products and services to you. AdelFi does not jointly market our products and services
